International Advisory Board meeting at HAC

The HAC's International Advisory Board held its annual meeting in Budapest on 26-27 October 2012. Together with nine HAC members on the first day meeting the Board discussed the main changes at HAC since the establishment of the new body in March 2012. HAC President Ervin Balázs informed the Board about the composition and tasks of the new HAC in office. On day 2 the Board discussed the HAC report on 2011/12 activities and issues related to the coming external evaluation of HAC.

NCPA grants accreditation to 22 programmes

Changes in the NCPA Accreditation Board composition

On 10 November 2012 the General Assembly of the National Guild of Experts in Higher and TVET Education adopted amendments to the composition of the NCPA Accreditation Board which was increased to 24 members representing Russian academic and research communities, student associations and state authorities. The Chair of the NCPA Accreditation Board is Dr. Victor Bolotov, Vice President of the

Russian Academy of Education. The recent session of the Board took place on 7 December 2012 in Moscow, as a result of which accreditation was granted to 21 study programmes delivered by two Federal Universities of Russia.

New director at NAA

News from NAA

- On the 15 of November Alexey Postnikov was appointed Director of NAA
- On the 12-13 and on the 15-16 November NAA conducted two seminars for experts, quality assurance professionals, and the leadership of Higher Educational Institutions
- The issues of quality indicators and criteria as well as the problems of methodological provision and support of the procedures of state accreditation were discussed
- NAA's activities in 2012:
 - 730 HEIs have undergone the external evaluation with the purpose of establishing the status of a state institution of higher professional education;
 - 6879 programs have been accredited;
 - 595 post-graduate programs have undergone external review.

SKVC to develop subject benchmark statements in the framework of SKAR-2

Development of subject benchmark statements in Lithuania

During the next two years the Centre for Quality Assessment for Higher Education (SKVC) will be **developing benchmark statements** for different discipline areas, all together about 50 to cover subject fields. They will be to follow for program designers and as a reference point for program reviewers as well, and thus, naturally, will serve as guiding documents to be observed in internal processes at higher education institutions.

The descriptions are produced by local teams in which stakeholders are involved.

During the period of 2004-2012, SKVC has already coordinated writing and approval of more than 20 descriptions of various subjects. However, there is a need to update subject field descriptions with recent trends in education such as offering student-centred learning, creating descriptions in cooperation with labour market representatives, and to firmly base study program creation, implementation and evaluation on learning outcomes.

Developing a national study fields' description system that regulates higher education studies and creates conditions for improvement of quality in higher education is the main aim of European social fund and Republic of Lithuania financed project "Development of study fields' descriptors regulating system" (SKAR-2).

External review of EKKA completed

Estonian Higher Education Quality Agency (EKKA) is undergoing an External Review by ENQA

As Estonia has made a transition to a new external quality assurance system in higher education after the transitional period that lasted from 2009 to 2011. EKKA has launched **new types of external quality assurance** activities, such as **institutional accreditation** and **assessment of study programme groups** in all higher education institutions. In order to become a full member of the European Association for Quality Assurance in Higher Education (ENQA) and be included in the European Quality Assurance Register for Higher Education (EQAR), EKKA decided to apply for an external review of the agency in January 2012. This **review has been coordinated by ENQA**, who has approved the panel consisting of the following members:

Séamus Puirséil, President of the Dublin Business School, Ireland - Chair

Aurelija Valeikiene, Deputy Director of the Centre for Quality Assessment in Higher Education (SKVC) – Secretary

Riitta Pyykkö, Professor of Russian Language and Culture at the University of Turku, Vice-Rector of the University of Turku since August 2012, Chair of the Finnish Higher Education Evaluation Council (FINHEEC)

Jean-Pierre Finance, Provisional administrator of the university of Lorraine, France, and advisor for EU at the CPU (French university rectors conference) – EUA nomination

Allan Päll, student at the University of Tartu, Estonia – ESU nomination

The panel visited EKKA on 6-7 December 2012 and met the rectors of the Estonian higher education institutions, external evaluation experts and students as well as the Minister of Education and Research, EKKA Quality Assessment Council and the Board member of the Archimedes Foundation.

The process of self-evaluation at EKKA started already one and a half years before the actual site visit. EKKA prepared a self-evaluation report that analyses its activities and compliance of the Estonian Higher Education Quality Agency with the European Standards and Guidelines for external quality assurance agencies and with the membership criteria of ENQA. The <u>report</u> is available on EKKA website. As a result of the self-analysis, some of the regulations were changed and a <u>Quality Manual</u> was compiled.

EKKA will receive the report of the ENQA panel by the end of January 2013.



Foundation "Higher Education Quality Evaluation Centre" (HEQEC), Latvia

New regulations for accreditation of higher education institutions (HEI) and study directions (groups of study programs) in HEI entered in force on 19.10.2012. According to the changes in the Law On Institutions of Higher Education (entered in force on 01.08.2011) the transition period from the study program accreditation to the study direction accreditation is from 01.09.2012 until 30.06.2013 All study





programs in HEI should be divided in groups according to the 29 study directions and should receive the new accreditation till 30.06.2013.

Till the end of the year 2012 Ministry of Education and Science should start competition to find an organization (quality assurance agency (QAA)), registered in EQAR, which should organize the evaluation and accreditation of all study directions in Latvia during the three year period.

HEQEQ is finishing the last evaluations and accreditation of individual study programs, submitted according to the previous (outgoing) regulations.

HEQEQ plans to participate in the new evaluations and accreditation of the study directions in Latvia, according to the new (incoming) regulations, as a local (national) partner of some foreign QAA (registered in EQAR), which will win the competition, organized by the Ministry of Education and Science.
